These certificates are presented annually. Clubs must complete the current Club Participation & Statistical Report on the following three pages. Please note that points are earned based on club participation in the areas of club administration, monetary contributions, membership and club extension, club representation, and leadership. A club does not have to have winning reports to earn points but have at least participated and reported in these areas. A minimum of 100 points must be earned to receive this distinction. This form is to be sent to the Vice President along with club reports by February 1.

PRESIDENT'S CUP

The CLUB PARTICIPATION AND STATISTICAL REPORT FORM is due by February 1 of each year along with club reports. It should contain information on club activities from January 1 through December 31 of the previous year. Copies of the report should be sent to the MFWC Vice President, Sherri E. The Club Participation and Statistical Report will determine those clubs that will receive the MFWC President's Cup.

GFWC-MFWC President's Cup will be awarded in four classifications:

- Classification A: Under 20 members
- Classification B: 21 – 35 members
- Classification C: 36 – 50 members
- Classification D: 51+ members

Please note that the GFWC Special Projects, GFWC Community Service Programs and GFWC Advancement Areas club awards are not determined by this information. An appropriately completed MFWC Reporting cover sheet and a narrative report must be submitted to receive that designation.
