- 1. Applicant Requirements
 - a. Application for this scholarship is to be made by letter to the GFWC-MFWC President and **postmarked by March 1** of each year. Mail application and supporting materials to Theresa Buntyn, GFWC-MFWC President, P. O. Box 355, Decatur, MS 39327. Please note: if the postmark deadline falls on a Sunday or Holiday, the application/form must be postmarked prior to postmark date.
 - b. Applications must include the following additional information:
 - i. Photograph of applicant. Please do not staple or paperclip photograph to application.
 - ii. Resume that includes appropriate high school/community and Juniorette club activities, including all awards and positions of leadership
 - iii. A letter of recommendation from the GFWC-MFWC sponsoring club advisor or club advisors to the Juniorette Club in which the applicant hold membership.
 - iv. A letter of recommendation from the GFWC-MFWC sponsoring club's president.
 - v. The scholarship committee would like, but it is not required to win the scholarship, a 250-word maximum essay to the following prompt: Why has volunteering as a Juniorette been important to you?
